

Introducing Continuing Education Program for RUCKUS Partners

RUCKUS® Networks has now made qualifying for training, accreditation and certifications easier to maintain for our upper-level Partners. With our new Continuing Education program, Certified and Elite Partners can extend their qualification for one additional year without having to undergo the accreditation and certification process.

To qualify, simply attend or participate in the designated classes or activities, and earn points. Accumulate enough points during a compliance year (July 1 through June 30) and your qualifications will be extended for one additional year.

Use the Continuing Education program to make sure your company maintains the correct number of qualified sales, technical and certified professions to retain your Certified or Elite Partner status.

Here's how it works

1. Sign up for an online course or activity on the [CommScope University](#) or [RUCKUS Technical Family website](#).
2. Complete the course or activity as instructed and receive points.
3. Accumulate enough points and you'll automatically receive a one-year extension to your qualifications.

That's all there is to it!

How points are awarded

For each class or event, you'll earn the following points after your participation has been validated.

Point requirements

Earn enough points in one compliance year and you'll get an additional year extension to your qualifications. You can earn a 12-month extension each year to avoid having to go through RUCKUS certification.

10 points	Sales and SE pre-sales training
15 points	Sales and SE pre-sales training and technical trainings and accreditations
20 points	Sales and SE pre-sales trainings, technical trainings and accreditations and certifications

You must be an active Certified or Elite Partner to participate.

Expired trainings, accreditations, and certifications are not eligible for extensions.

Points earned will only be good in the compliance year in which it was earned.

Points can only be earned and redeemed per individual basis. Sorry, no tag teams allowed.

12-month extension can only be earned once during a compliance year.
